1. Battered Wife/Women

2. Abuse Children

3. VAWC Victim

What are the Requirements:

1. Referral letter from CSWDO or MSWDO

2. Social Case Study (from the Social Worker)

3. Affidavit or Investigation Report from the PNP

4. Medical Certificate

5. Birth Certificate
