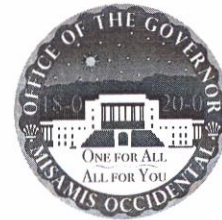

## INVITATION TO BID FOR

# PROCUREMENT OF 1,300 PCS. EPOETIN ALFA (RECOMBINANT HUMAN ERYTHROPOIETIN) 4,000 IU/0.4ML PREFILLED SYRINGE FOR MISAMIS OCCIDENTAL PROVINCIAL HOSPITAL (REBID)

1. The Province of Misamis Occidental through the Drug Revolving Funds<sup>3</sup> intends to apply the sum of **Seven Hundred Fifteen Thousand Pesos (P715,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **above named project**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Province of Misamis Occidental now invites bids for **Procurement of 1,300 pcs. Epoetin Alfa (Recombinant Human Erythropoietin) 4,000 IU/0.4mL Prefilled Syringe for Misamis Occidental Provincial Hospital (Rebid)/PB-G-DM-25-2019-09-583**.<sup>4</sup> Delivery of the Goods is required within **15 calendar days**. Bidders should have completed, within the period of (3) *years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from the BAC Secretariat at the Provincial Governor’s Office, 4<sup>th</sup> Floor New Capitol Building, Capitol, Oroquieta City, Misamis Occidental and inspect the Bidding Documents at the address given below during office hours **Mondays to Fridays from 8:00a.m.-5:00 p.m.**

<sup>3</sup> In the case of National Government Agencies, the General Appropriations Act and/or continuing appropriations; in the case of GOCCs, GFIs, and SUCs, the Corporate Budget for the contract approved by the governing Boards; in the case of (LGUs, the Budget for the contract approved by the respective *Sanggunian*. (Section 5(a), R.A. 9184)

<sup>4</sup> A brief description of the type(s) of Goods should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **October 18, 2019 to October 25, 2019** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **₱ 1,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. Bids must be duly received by the BAC Secretariat at the address below on or before **October 25, 2019 at 8:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **October 25, 2019 at 8:30 A.M.** at *Provincial Governor's Office Conference Room, 4<sup>th</sup> Floor New Capitol Building, Oroquieta City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. **Late bids shall not be accepted.**

7. The Province of Misamis Occidental reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
