Invitation to Bid for
Procurement of Works for Upgrading of Sulipat-San Isidro-Quibol
Provincial Road Calamba, Misamis Occidental.

1. The *Province of Misamis Occidental*, through the *CMGP Program*³ intends to apply the sum of *Twenty Eight Million Four Hundred Ninety Nine Thousand Nine Hundred Eleven Pesos and 49/100 (P 28,499,911.49)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Upgrading of Sulipat-San Isidro-Quibol Provincial Road Calamba, Misamis Occidental/PB-I-2019-09-399-01-CMGP*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Province of Misamis Occidental* now invites bids for the *above mentioned civil works*⁴ Completion of the Works is required *150 Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the Bids and Awards Committee Province of Misamis Occidental and inspect the Bidding Documents at the address given below from *9:00 am-5:00 pm Mondays to Fridays*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *September 18, 2019 to October 08, 2019* from the address below *and upon payment of*

the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ₱ 25,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. *The Province of Misamis Occidental will hold a Pre-Bid Conference⁵ on **September 25, 2019 at 9:30 AM** at Provincial Governor's Office Conference Room, 4th Floor, New Capitol Building, Oroquieta City, which shall be open to prospective bidders.*
7. *Bids must be duly received by the BAC Secretariat at the address below on or before **October 08, 2019**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.*

*Bid opening shall be on **October 08, 2019 at 9:30 AM** at the Provincial Governor's Office Conference Room, 4th Floor New Capitol Building, Oroquieta City, Misamis Occidental. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.*

8. *The Statement of the Single Largest Completed Contract (SLCC) of the prospective bidders shall be at least 50% of the Approved Budget of the Contract as stated herein.*
9. *The **Province of Misamis Occidental** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.*
