Invitation to Bid for
Procurement of Civil Works for the Rehabilitation of Capitol Drive Front Road and Improvement of Capitol Park and Street Lights

1. The ***Provincial Government of Misamis Occidental***, through the ***General Funds 2020***³ intends to apply the sum of ***Twenty-two Million Three Hundred Thirty-two Thousand Three Hundred Forty-seven Pesos and 27/100 (Php. 22,332,347.27)*** being the Approved Budget for the Contract (ABC) to payments under the contract for ***PB-I-2020-05-615 Procurement of Civil Works for the Rehabilitation of Capitol Drive Front Road and Improvement of Capitol Park and Street Lights***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The ***Provincial Government of Misamis Occidental*** now invites bids for the above mentioned works.⁴ Completion of the Works is required ***194 Calendar Days***. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from *the Bids and Awards Committee of the Provincial Government of Misamis Occidental* and inspect the Bidding Documents at the address given below from ***8:00 am-5:00 pm Mondays to Fridays***.
5. A complete set of Bidding Documents may be acquired by interested bidders on ***June 18, 2020 – July 13, 2020*** from the address below *upon payment of the applicable fee for*

*the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php. 25,000.00.***

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The ***Provincial Government of Misamis Occidental*** will hold a Pre-Bid Conference⁵ on ***July 1, 2020, 10:00 am at the BAC Conference Room, 3rd Floor, New Capitol Building, Oroquieta City*** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before ***July 13, 2020, 10:00 am.*** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on ***July 13, 2020, 1:00 pm at the BAC Conference Room, 3rd Floor, New Capitol Building, Oroquieta City.*** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. ***The statement of SLCC of prospective bidder shall be at least 50% of the ABC.***
9. ***Bidders based outside Misamis Occidental must include Business/Mayor's Permit from any City/Municipality in Misamis Occidental as one of the Eligibility Requirements for this procurement project.***
10. The ***Provincial Government of Misamis Occidental*** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
