



Invitation to Bid for *Procurement of Works for the Proposed Renovation of Provincial Capitol Lobby (REBID)*

1. The *Provincial Government of Misamis Occidental*, through the *General Funds 2019*³ intends to apply the sum of *One Million Five Hundred Twenty Thousand Nine Hundred Thirty-seven Pesos and 73/100 (Php. 1,520,937.73)* being the Approved Budget for the Contract (ABC) to payments under the contract for *PB-I-2019-12-1246: Procurement of Works for the Proposed Renovation of Provincial Capitol Lobby*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Provincial Government of Misamis Occidental* now invites bids for the above mentioned works.⁴ Completion of the Works is required *120 Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *the Bids and Awards Committee of the Provincial Government of Misamis Occidental* and inspect the Bidding Documents at the address given below from *8:00 am-5:00 pm Mondays to Fridays*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *August 5, 2020 – August 25, 2020* from the address below *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php. 5,000.00*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The ***Provincial Government of Misamis Occidental*** will hold a Pre-Bid Conference⁵ on ***August 13, 2020, 10:00 am at the BAC Conference Room, 3rd Floor, New Capitol Building, Oroquieta City*** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before ***August 25, 2020, 10:00 am***. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on ***August 25, 2020, 10:00 am at the BAC Conference Room, 3rd Floor, New Capitol Building, Oroquieta City***. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. ***The statement of SLCC of prospective bidder shall be at least 50% of the ABC.***
9. ***Contractors/Prospective Bidders based outside Misamis Occidental must include Business/Mayor's Permit from the City/Municipality in Misamis Occidental as one of the Eligibility Requirements for this procurement project.***
10. The ***Provincial Government of Misamis Occidental*** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
