**Invitation to Bid**  
*for*  
**Procurement of Pipes for Transmission and Distribution, Solar Pumps for Water System**

1. The Province of Misamis Occidental through the **General Funds** intends to apply the sum of **Nine Million Six Hundred Fifty Thousand Fifteen and Sixty Centavos (P 9,650,015.60)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of Pipes for Transmission and Distribution, Solar Pumps for Water System** with contract ID **2020-07-1116**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Province of Misamis Occidental now invites bids for the aforesaid procurement project. Delivery of the Goods is required **fifteen (15) calendar days**. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the Bids and Awards Committee Province of Misamis Occidental and inspect the Bidding Documents at the address given below from 9:00 am-5:00 pm Mondays to Fridays.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **August 05, 2020 – August 25, 2020** from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (P 10,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity (<https://misocc.gov.ph/invitation-to-bid/>), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Province of Misamis Occidental* will hold a **Pre-Bid Conference** on August 13, **2020 10:00 AM** at the Conference Room, 3<sup>rd</sup> Floor New Capitol Building, Oroquieta City, Misamis Occidental, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before the scheduled date and time. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The bidders shall drop one (1) copy of original and two (2) copies of their bids containing the technical and the financial component of the bid, in separate sealed envelopes in the bid box located at the above-mentioned address.
9. The Province of Misamis Occidental reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
